Nepali Society of Northern Tasmania was established in 2018 with an aim to unite the diaspora Nepalese community residing in Northern Tasmania. Nepali Society of Northern Tasmania is a non-profit community organization that aims to promote the culture and language of Nepali origin. We organize cultural festivals, community events, educational, & awareness programs from which our community can benefit. We run campaigns like blood donation, domestic violence awareness, migrant rights, financial literacy, and social awareness advocacy. We also run fundraising campaigns for disaster relief and any unfortunate events where community members need community help. We also run our flagship program, Bhashalaya, where we aim to teach Australian-born Nepali kids our unique language and culture through activities and weekly classes and where parents, kids and visiting grandparents from Nepal get an opportunity to come together every Saturday from 10 – 12 p.m.

We are living in one of the most linguistically and culturally diverse demography. Coming from different backgrounds often manifests in a more challenging environment for any new migrant. To make a new place a home, we need an inclusive society where we can practice our cultural traditions. As an organization representing the Nepalese community, we aim to felicitate our people to help make their transition easier by providing an inclusive and collaborative environment.

Goddess Durga is adored and sacrificed to, representing value and pawns, to guarantee the success and prosperity of her believers.

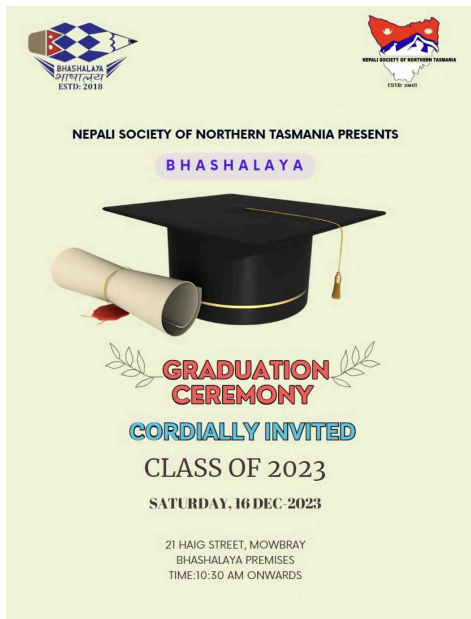

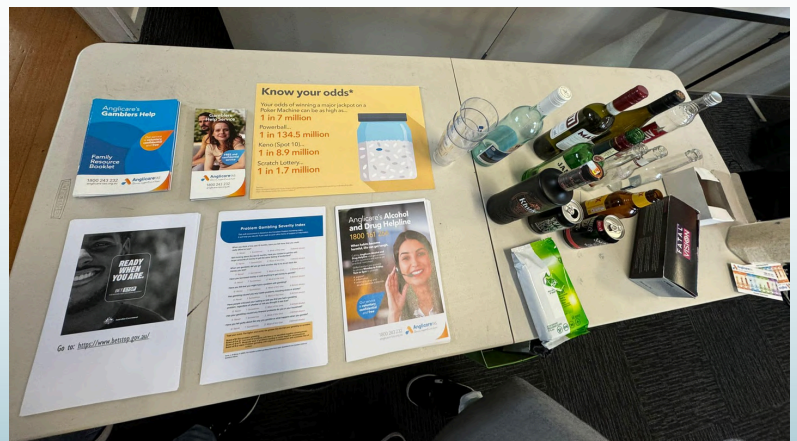
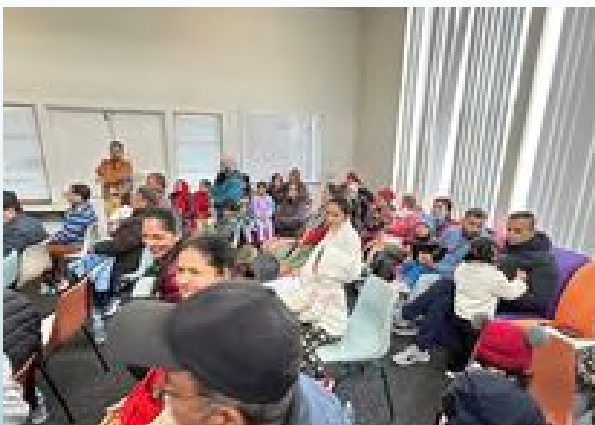

We have included pictures from our events that we completed during this tenure in every page of the calendar.



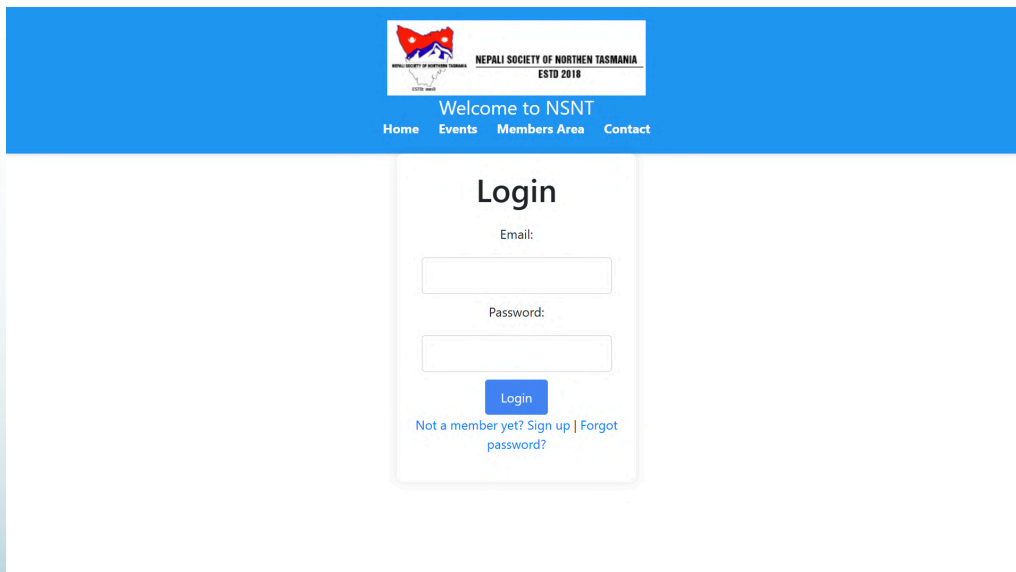
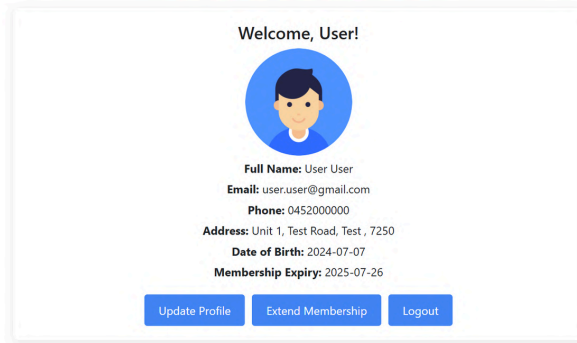
New Website For NSNT


Significant Changes

Going Concern



Successful Project Completion



Notes to the Financial Statements

Nepali Society Of Northern Tasmania For the year ended 30 June 2024

1. Summary of Significant Accounting Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act Tasmania. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

It is essential to note that historically, the fixed assets register was not maintained. As a result, assets acquired in prior years have not been included in the newly established fixed assets register for the 2023 financial year.

Cash on Hand

Cash on hand includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

These notes should be read in conjunction with the attached compilation report.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.

Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.


